## A 670M€ national strategy to implement 5 areas to support innovation

Within the "France Innovation Health 2030" framework and in synergy with the digital health national plans (digital health roadmap, "Ségur numérique", ...), the French government has launched the "digital health" acceleration strategy with the aim of making France a global digital health leader.



Foster the conditions for successful large-scale deployment

Implement real-life experiments and first industrial stages

Support the maturation of structuring projects and strengthen the strategic advantage

Prepare the future generation of key digital health technologies and facilitate the rapid transfer mechanisms of **research** results

Develop stakeholder **training**, trust in and professional attractiveness of the sector
