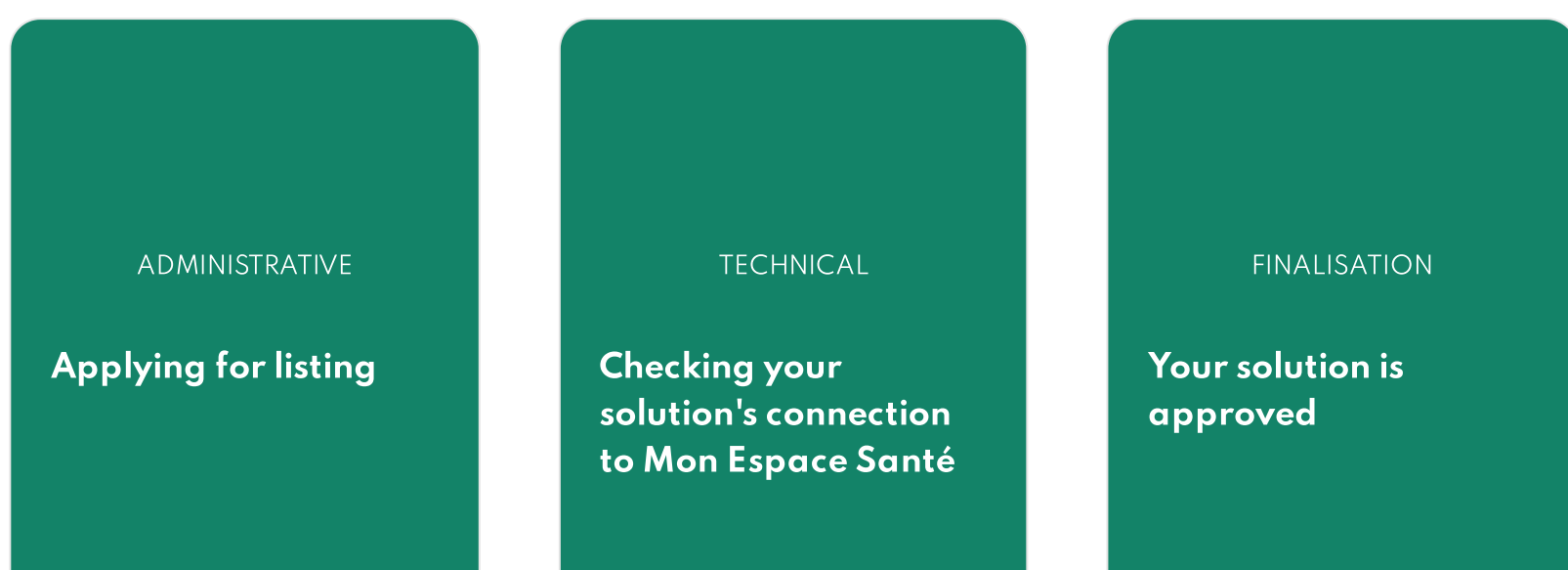
### Preparatory phase

### Listing phase

Learn about all the steps involved in submitting your application to have your digital solution listed. The technical stage does not concern solutions without data and document exchanges with Mon espace santé



## Our tips for saving time

### Adopting the HL7® FHIR® standard

- HL7® FHIR® is the latest interoperability standard in the field of healthcare. It is a standard that is simple and fast to implement. It offers:
  - a catalogue of resources, objects representing actors or concepts from the domain. For example: the Patient resource represents a patient, Appointment represents an appointment, Observation a health measurement, etc.
  - And the methods of exchanging these resources based on the latest web technologies, in particular a REST API

### Adopting the interoperability framework

- The interoperability framework for health information systems, or CI-SIS, sets out the rules for medical IT applications with the ability to communicate. It consists of a set of functional and technical specifications, based on international standards, with the aim of facilitating communication and information sharing in the fields of health care and social care.
- Some components of the interoperability framework apply to the use of Mon Espace Santé resources, in particular the Shared Calendar Management component, the Mobile Health Records Sharing component, and the business-layer components which specify the structured format of health documents that can be included in the Shared Medical Record (DMP).

### Schedule

- The listing process and registration tools are currently being co-constructed and will be available starting in:
  - August 2021 for the "Convergence" tool
  - November 2021 for the "Publisher Portal"

- January 2022 for the Catalogue of Listed Services

- Beginning in autumn 2021, a "sandbox environment" of the Mon Espace Santé platform will be made available to test the compliance of the services and apply to have them listed. The "Convergence" and "Gazelle" tools will be accessible via this platform.
- A platform for testing APIs and test sets to go with it will also be made available starting in autumn 2021.

## What the listing process is and isn't

- **It is a process** to ensure that candidate digital tools are aligned with technical requirements and sectoral best practices
- **But it is not a labelling or certification process**, nor an assessment of whether the candidate digital tools comply with all applicable regulations (e.g. GDPR), nor an assessment of medical usefulness

## 02. I log in to my Convergence account

### I do not yet have an account on the Convergence platform

- We invite you to download the registration form directly and, once completed, to send it to our team who will take care of your registration within 24 hours (average delay). Download the registration form [here](#).
- Once you have registered, you will receive an e-mail to confirm your registration and access the Convergence Portal.

Supporting documents to be provided: company's kbis / copy of a valid ID of the corporate officer.

### 03. I assess the maturity level of my solution

#### I take the referral path to Mon espace santé in Convergence

- I fill in the information required in the Mon espace santé section of the Convergence platform either in the Referral without data exchange approach or in the Referral with data exchange approach.
- I fill in the information required in the Mon espace santé section of the Convergence platform either in the Referral without data exchange or in the Referral with data exchange section. In Convergence, information concerning the ethical criteria is expected. To fill in this information, you will need to use the [Ecoscore](#) tool. Please note: it is necessary to have a technical profile to use the Ecoscore.
- You must retrieve from the platform the Convergence product reference of the solution you wish to reference and the extraction of the results of the questionnaires filled in on the Convergence platform and send them to GIE SESAM-Vitale to officially enter the referencing process in the catalogue of services of Mon espace santé.

# Applying for listing

## 04. Your preliminary application is studied

ADMINISTRATIVE

GIE SESAM VITALE

### The eligibility of your digital service is evaluated

Complete the documents to enter the listing process:

- Fill out the **preliminary form** before filing the listing application. This form can be downloaded from the [listing portal](#)
- Send it to [referencement@mes.sesam-vitale.fr](mailto:referencement@mes.sesam-vitale.fr) with an extraction (in Excel format) of the results of the questionnaires filled out on the Convergence portal
- You're officially entered in the listing process for the Mon Espace Santé service catalog

### The GIE SESAM approves the eligibility of your application

If your application is eligible and compliant, GIE SESAM-Vitale will send you a **personalized listing package** as well as **the agreement to sign**

Your application is eligible if:

- Your digital solution complies with the eHealth technical framework at the levels expected by Mon Espace Santé.
- Your digital solution is relevant for listing. To find out if you're affected, see the page [Checking if your digital service is applicable](#) on the G\_NIUS site.
- This check is done on a declarative basis, with no evidence expected.



## 05. Submitting your file

## 06. Your file is reviewed

ADMINISTRATIVE

### Your listing file is evaluated

- The team of experts in charge of the evaluation analyses your listing file and the evidence of compliance.
- Respond to any requests (for additional information, or to deal with non-compliances).
- The evaluated service is studied in a listing commission during which an evaluation report of the candidate service is prepared, with one of the following "opinions": unfavorable, favorable with conditions attached, and unconditionally favorable.

### Running tests to connect to Mon Espace Santé

- Run the **technical tests** to connect to the APIs and submit an **acceptance file** to the testing team for the listing process:
  - If your file is satisfactory: You'll receive the terms and conditions for testing the connection to the Mon Espace Santé APIs in order to validate the integration of your solution.
  - If your file is unsatisfactory: Start over and/or perform additional tests

### Getting approval from the independent commission

- You've fulfilled the **three conditions**:
  - The commission has given a **favorable opinion**
  - The Minister of Health has issued a listing decision
  - The **technical tests** for connection to APIs have been **passed**
- You get a listing notification, accompanied by the decision of the Minister of Health

## 08. Your service is published

### Listing of your service

- **Your service is listed** and appears in the catalog of services in Mon Espace Santé.
- Your service has earned the right to be listed for a period of **one year**, renewable upon its completion by filing a new application.
