


My Referencing roadmap and Segur Financing


Getting to know you

I am aware of the resources available to me and the program schedule.



Technical preparation and sales launch

I'm upgrading my solution to comply with Ségur requirements, anticipate CNDA procedures, and launch my sales campaign. These activities can be carried out in parallel.

Financing request

Once I'm registered, I can start applying for financing. I start by registering with ASP, submitting my funding applications, and then receiving my advance.

01. I identify the base documentation that concerns me

START ANS

I identify the lane(s) I'm interested in. I download the reference documentation for the lane and software I'm applying for.

Go to **the ANS Segur page**: I choose my corridor, and discover the various associated reference documents.

On the page corresponding to my corridor, I download and read the reference documents:

- **The Requirements Repository**, which consolidates all the requirements with which solutions applying for Segur labeling must comply, as well as the compliance scenarios and expected proofs, associated with these requirements.
- **The DSR (Dossiers de Spécifications de Référence)**, which sets out the technical and functional requirements to be met to obtain Segur referencing for a solution
- **The Call for Funding**, which spells out the administrative and financial terms and conditions, including the funding scales available based on parameters specific to each corridor

03. Bringing my solution into line with my corridor's DSR and software type

TECHNICAL ANS

I identify the requirements specific to the referencing specification file that concerns me

These requirements imply an evolution of Information Systems in order to be compatible with the following core reference systems and services:

- The National Health Identity (INS), enabling the secure exchange and sharing of healthcare data around a reference identity, up to date and common to all players: [link to the GNUS guided path](#)
- The DMP feed, My Health Space resource for transmitting documents to patients and sharing with authorized healthcare professionals: [en savoir plus sur le DMP](#)
- The transmission via MSSanté of patient information within a care path logic: [en savoir plus sur MSSanté](#)
- The integration of Pro Santé Connect for professional authentication in their IS: [learn more about ProSanté Connect](#)
- Compliance with the Health IS Interoperability Framework (CI-SIS): [learn more about CI-SIS](#)

For all the corridors, these IS must also meet a portability requirement enabling all the healthcare data and correspondent information they process to be made available.

In addition, specific requirements by corridor / type of software have also been defined and are mentioned in the DSR.

It is necessary to anticipate this step well, which is a prerequisite to the application for referencing

04. I anticipate the steps to be taken with the CNDA

ADMINISTRATIVE CNDA

The CNDA is the National Center for Deposit and Approval.

Delay 6 weeks

This organization authorizes your software to use the teleservices implemented by Assurance Maladie.

Proof of filing an application for approval with the CNDA is one of the documents required to apply for Sécurité sociale referencing.

It can take up to 6 weeks for CNDA approval to be issued.

It's important to anticipate this step, which is a prerequisite to the referencing application

I launch sales preparation actions

I can launch sales actions to obtain pre-orders "subject to obtaining my listing"

05. I approach my customers and prospects to obtain orders

COMMERCIAL PUBLISHER

I launch my commercial canvassing campaigns

I don't have to wait to be listed with ANS to start my sales efforts.

To speed up the process and save time for manufacturers, the public authorities allow me to launch my commercial canvassing activities from the outset to obtain orders "subject to referencing".

I can use the "practical sheets" available to me to present the Segur Program to my customer, informing them of its prospects and the opportunities it brings. These practical sheets can be downloaded from the ANS website, on the page for my corridor.

I can use the "practical sheets" made available to me to present the Segur Program to my customer, informing them of its prospects and the opportunities it brings.

Practice sheets for General Practice, Biology, Radiology, Hospital and Operators are published.

Please note:

From the order "under the condition of referencing", I have 120 days to bring my proofs of compliance when applying for referencing to the ANS.

06. I am applying to the CNDA for approval

ADMINISTRATIVE CNDA

I sign the special condition with the CNDA

- Signing this condition enables the publisher to access the deliverables required for the compliance request and to receive the test components (Vitale cards).

I contract

I don't have an account on the CNDA personal space yet?

Delay 5 days to open an account

Important: This access request requires the involvement of the legal representative or a delegation of authority on his or her part.

Create an account

When I open my account, I retrieve my test data

Delay 6 weeks

- The CNDA will send you the LPS authorization number to access the publisher test environment.
- You will receive the test set of Vitale cards if Vitale card reading is to be implemented at your customers.

Important: CNDA will not issue you test CPx cards **or test certificates**. If you don't already have test cards **or test certificates**, or these **last** expire, you'll need to order some from the CNDA. **To do this, consult the procedure for ordering these test products.**

07. Create my account and submit my referencing application

ADMINISTRATIVE ANS

I create my account on the application tool

Delay 6 weeks

The CNDA approval procedure is finalized and I have my CNDA identifiers. I can now start the referencing process.

I create my account on the ans.wiin.io page, the Segur application submission portal

I would like to be listed

To make my request, I select the DSR that applies to me.

It is possible to submit several applications for the same DSR, just as it is possible to apply for several DSRs. All my applications will be visible on my space.

I submit my eligibility form

A series of information is requested,

- concerning the publisher: contact details of the person legally responsible, company name, publisher identification number (NIE issued by the CNDA), SIRET number;

- concerning the software subject of the request: name and version of the software, software identification number (NIL issued by the CNDA), software profile and letter of commitment;

If I'm a representative of a group of publishers, I'll need to provide all the mandates of the group's partners. I can also specify whether my software is marketed via mandated distributors.

When I submit my application, the ANS may come back to me to complete / clarify my file. I make sure to respond to ANS requests within 24 hours to avoid lengthening my processing time!

I receive confirmation of my eligibility

Delay 1 week

I sign the referencing agreement electronically. I receive my access accounts for the necessary tools (convergence, gazelle, ...). I receive an email confirming my eligibility and I can access my proof collection space.

08. I provide proof of compliance

ADMINISTRATIVE ANS

When my eligibility is validated, I provide proof of compliance for each requirement of each DSR.

As a reminder, the list of requirements, compliance scenarios and expected proofs are described in the Requirements Repository for my corridor (which I read about in step 1 of my journey).

When I submit my application, I make sure to remain available in the event of a request for information or clarification from the NSA.

ADMINISTRATIVE ANS

Obtaining referencing

Delay 6 weeks

Once my application for referencing has been processed and validated, my referencing will be issued. My software will appear in the list of solutions referenced by Ségur for this DSR.

10. I submit my enrolment request to ASP

L'agence de services et de paiement is the public operator responsible for paying Ségur numérique funding to solution providers who have previously obtained Ségur referencing for the service provided to their customer.

ADMINISTRATIVE ASP (SERVICES AND PAYMENT AGENCY)

I register on the ASP platform

Enlistment is a mandatory prerequisite for submitting funding and payment requests.

Who is eligible?

- Any publisher of a solution referenced by the ANS and as long as this solution is actually offered for sale;
- Any distributor of a solution referenced by the ANS (declared as such to the ANS and having a mandate established by the Publisher) and as soon as this solution is effectively proposed for marketing;

1. I fill in the enrolment form directly on the [ASP platform](#). This form contains the following information:

- The SIRET number, the legal representative, the custodian of the request if not the legal representative, as well as contact and payment details;
- The unique Software Solution referencing number issued by the ANS upon referencing;

2. I enclose the following documents with my application:

- The certificate (referencing report) issued by the ANS ;
- The RIB ;
- The identity document (CNI, Passport or Residence permit) of the person submitting the application, or, if he or she is not the legal representative, the attestation certifying that he or she has the necessary powers to complete the formalities; (If the application is made by the distributor, I enclose the mandate drawn up by the publisher certifying that I am mandated as an authorized distributor of the referenced solution.

As a reminder, the administrative and financial terms and conditions, in particular the funding scales available according to parameters specific to each corridor, are available in the **Call for Funding** for my corridor/software and downloadable from the ANS Segur page.

11. I apply for financing

ADVANCE PAYMENT ASP (SERVICES AND PAYMENT AGENCY)

I apply for financing

Once enrolled, I can log on to the ASP page and submit my funding application. When this funding request is validated, I receive my 30% advance.

Getting my financing is conditional on:

- My pre-registration
- Conditions relating to the **beneficiary** of the Service
- Conditions relating to the **perimeter** of the Segur Benefit:
- Conditions relating to the **eligibility of the order** :
- Conditions relating to the **methods of supply** of the Segur Service
- Details of eligibility conditions are specified in my **Call for Financing**.

I log on to the ASP Platform and submit my funding application form, along with the purchase orders signed by the associated customers.

ADVANCE PAYMENT ASP (SERVICES AND PAYMENT AGENCY)

ASP processes my file.

If I meet all the conditions, I am notified that my application has been validated, so I receive:

- The decision to award my financing
- The payment of my 30% advance

13. I carry out the Segur service on my customer's premises

INSTALLATION CUSTOMER

My financing is approved, and I start the Prestation Sécur work on my customer's premises.

As a reminder, the benefit paid by the state covers:

- The user license on the perimeter covered by the DSR
- Installation, configuration and qualification costs
- Corrective maintenance on the scope covered by the DSR
- Support in obtaining an organization-type software certificate, when required
- Project follow-up and delivery of documentation
- Training of healthcare professionals

Terms and conditions for the provision of the Segur Service are available on the Call for Funding for my corridor/software

I note that:

- My financing comes in return for the complete provision of the Segur Benefit, in all its components and at no extra cost to the customer.
- I undertake to include in the GCU applicable to the referenced solution a clause allowing the provision of data in a readable, exhaustive, usable, and documented format, as specified in the regulatory texts relating to my corridor
- The Segur Service cannot be made conditional on a contractual recommitment by the customer

14. I request payment of the balance

REMAINING PAYMENT ASP (SERVICES AND PAYMENT AGENCY)

Once the Prestation Sécur has been completed, I can request payment of my balance on the ASP platform.

The documents making up my file vary according to my corridor and my software. These are to be consulted on the Call for Funding.

I log on to the [ASP Platform](#), submit my balance claims and the following supporting documents:

- The copy of the invoice issued for the End Customer
- As the case may be, the Mise en Ordre de Marche (MOM) declaration or a Verification d'Aptitude from my customer attesting to the successful completion of the Segur Prestation

15. I receive my balance

REMAINING PAYMENT ASP (SERVICES AND PAYMENT AGENCY)

ASP processes my file.

If I meet all the conditions, I am notified that my application has been validated and I receive payment of my 70% balance.
